#### 3. HIPAA & Protected Health Information

If you are a patient, your PHI is protected under the Health Insurance Portability and Accountability Act (HIPAA). We will not use or disclose your PHI except as permitted or required by law, such as:

- For treatment purposes (coordination of your care)
- For payment and insurance purposes
- For healthcare operations (quality improvement, training, audits)
- When required by law (e.g., court order, public health reporting)

You will receive a **Notice of Privacy Practices (NPP)** separately, which explains in detail how we handle your PHI.

### 4. How We Share Information

We do not sell your personal information. We may share information only in the following cases:

- With trusted service providers who support our operations (e.g., secure electronic health record providers, billing services)
- As required by law or court order
- In connection with business transfers (e.g., merger or acquisition)

All vendors handling PHI must comply with HIPAA requirements.

## 5. Data Security

We implement administrative, technical, and physical safeguards to protect your personal and health information, including secure servers, encryption, and limited access controls. While we strive to protect all data, no method of transmission over the internet is completely secure.



# 6. Your Rights

As a patient, you have rights under HIPAA, including:

- The right to access your health records
- The right to request corrections to your records
- The right to request restrictions on certain uses and disclosures
- The right to request confidential communications
- The right to receive an accounting of disclosures
